DESCRIPTION: With our Pivot Point program, the student will learn to see, think, create and adapt like a professional designer starting the first day of class. Our modular approach to teaching has students on a schedule where they focus on one core subject at a time. This makes the learning process easier AND teaches the 'why,' not just the 'how', of the design process. The program includes 500 clock hours of classroom training (Academic Instruction), and 700 clock hours of service requirements (Practical Applications) under the supervision of a Florida Licensed Cosmetologist.

OBJECTIVE: The objective in the cosmetology program is to train students in the Skills needed to meet the competencies for the examination required by the State Board of Cosmetology. Hollywood Institute of Beauty Careers offers a Cosmetology Program that prepares the student to meet the educational requirements of the Department of Business and Professional Regulations and Florida Administrative Code. Upon successful completion of the program, a diploma will be awarded and the graduate will be eligible for the State Board exam required for licensure.
